**INTRODUCTION**

The purpose of this circular is to provide you with information regarding certain ordinary resolutions to be proposed at the AGM to enable you to make an informed decision on whether to vote for or against those resolutions.

At the AGM, resolutions will be proposed for the Shareholders to approve, among other things:

- (i) the Repurchase Mandate;
- (ii) the Issue Mandate;
- (iii) the Extension Mandate; and
- (iv) the re-election of Directors.

The full text of these resolutions is set out in the notice convening the AGM.

### **REPURCHASE MANDATE**

On 25 June 2018, a general mandate was granted to the Directors to exercise the powers of the Company to repurchase Shares. Such mandate will lapse at the conclusion of the AGM. An ordinary resolution will be proposed at the AGM to approve the Repurchase Mandate. As at the Latest Practicable Date, the Company had 1,260,582,340 Shares of HK\$0.005 each in issue. Subject to the passing of an ordinary resolution approving the Repurchase Mandate and on the basis that the total number of Shares in issue remains the same from the Latest Practicable Date up to the date of passing such resolution, exercise of the Repurchase Mandate in full would result in up to a maximum of 126,058,234 Shares, representing 10% of the total number of Shares in issue, being repurchased by the Company. An explanatory statement as required under the GEM Listing Rules to provide the requisite information of the Repurchase Mandate is set out in Appendix I to this circular.

### **ISSUE MANDATE AND EXTENSION MANDATE**

At the AGM, an ordinary resolution will be proposed to approve the Issue Mandate in order to ensure flexibility and discretion to the Directors to issue new Shares. As at the Latest Practicable Date, the Company had 1,260,582,340 Shares of HK\$0.005 each in issue. Subject to the passing of an ordinary resolution approving the Issue Mandate and on the basis that the total number of Shares in issue remains the same from the Latest Practicable Date up to the date of passing such resolution, the exercise of the Issue Mandate in full would result in up to a maximum of 252,116,468 Shares, representing 20% of the total number of Shares in issue. Such Shares may be issued by the Company during the period ending on the earliest of the conclusion of the next annual general meeting of the Company or the date by which the next annual general meeting of the Company is required to be held by law or the date upon which the Issue Mandate is revoked or varied by an ordinary resolution of the Shareholders at a general meeting of the Company. In addition, an ordinary resolution in relation to the Extension Mandate will be proposed to extend the Issue Mandate by adding to it such number of Shares repurchased under the Repurchase Mandate.

### RE-ELECTION OF DIRECTORS

As at the Latest Practicable Date, the Board consisted of four executive Directors, namely, Mr. Chan Wai Lung (Chairman of the Board), Ms. Lam Ching Yee (“**Ms. Lam**”), Ms. Lin Ting (“**Ms. Lin**”) and Mr. Shi Shaowu, one non-executive Director, namely, Mr. Lo Yu Man (“**Mr. Lo**”), and three independent non-executive Directors, namely, Mr. Lam Kai Yeung, Ms. Lee Kwun Ling, May Jean (“**Ms. Lee**”) and Mr. Zhong Shi.

Pursuant to Article 112 of the Articles, any Director appointed by the Board to fill a casual vacancy shall hold office only until the first general meeting of the Company after his/her appointment and be subject to re-election at such meeting. Accordingly, Mr. Lo shall retire from office at the AGM and he, being eligible, will offer himself for re-election at the AGM.

Further, pursuant to Article 108(a) of the Articles, at each annual general meeting of the Company, one-third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation provided that every Director shall be subject to retirement by rotation at least once every three years. As such, Ms. Lam, Ms. Lin and Ms. Lee shall retire from office at the AGM and they, being eligible, will offer themselves for re-election at the AGM.

The nomination committee (“**Nomination Committee**”) of the Board has recommended the re-election of Ms. Lee to the Board, after reviewing the professional qualifications, skills, knowledge, relevant experience, working profile and other factors (including but not limited to gender, age, cultural and educational background as set out in the board diversity policy of the Company) of Ms. Lee in accordance with the nomination policy and the board diversity policy of the Company. The Nomination Committee has also assessed the independence of Ms. Lee by reference to the independence guidelines as set out in Rule 5.09 of the GEM Listing Rules and reviewed her annual written confirmation of independence. The Nomination Committee had evaluated the past performance of Ms. Lee and found her performance satisfactory. The Nomination Committee considered that Ms. Lee will continue to bring to the Board her own perspectives, skills and experience as further detailed in Appendix II to this circular and that she can contribute to the diversity of the Board, in particular, with her strong educational background and extensive work experience. Therefore, the Board is satisfied that Ms. Lee has the required character, integrity, perspectives, skills and experience to continuously fulfill her role as an independent non-executive Director effectively. The Board believes that the re-election of Ms. Lee as an independent non-executive Director would be in the best interests of the Company and the Shareholders as a whole.

The biographical details of each of Ms. Lam, Ms. Lin, Mr. Lo and Ms. Lee are set out in Appendix II to this circular.

### AGM

A notice convening the AGM to be held at Podium Level 6, vip Room III, L'Hotel Island South, 55 Wong Chuk Hang Road, Aberdeen, Hong Kong at 11:00 a.m. on Tuesday, 25 June 2019 is set out on pages AGM-1 to AGM-6 of this circular.

In order to determine the entitlement of the Shareholders to attend and vote at the AGM, the register of members of the Company will be closed from Thursday, 20 June 2019 to Tuesday, 25 June 2019 (both days inclusive), during which period no transfer of Shares can be registered. To qualify for the attendance and voting at the AGM, Shareholders must ensure that all transfer documents accompanied by the relevant share certificates are lodged with the Company's branch share registrar and transfer office in Hong Kong, Union Registrars Limited, at Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong not later than 4:00 p.m. on Wednesday, 19 June 2019.

Pursuant to the GEM Listing Rules, any vote of shareholders at a general meeting must be taken by poll. Accordingly, all the proposed resolutions will be put to vote by way of poll at the AGM. An announcement on the poll results will be made by the Company after the AGM in the manner prescribed under Rule 17.47(5) of the GEM Listing Rules.

Completion and return of the form of proxy will not preclude you from subsequently attending and voting in person at the AGM or any adjourned meeting should you so desire.

### COMPETITION AND CONFLICT OF INTEREST

Ms. Lam, an executive Director, is also a director of certain subsidiaries of Hang Tai Yue Group Holdings Limited (formerly known as Interactive Entertainment China Cultural Technology Investments Limited) ("**Hang Tai Yue**"), a substantial Shareholder, i.e. Mark Profit Finance Limited (which is a company principally engaged in money lending business in Hong Kong) and other subsidiaries of Hang Tai Yue which are principally engaged in assets investments business.

Save as disclosed above, as at the Latest Practicable Date, none of the Directors or their respective close associates (having the meaning ascribed to it in the GEM Listing Rules) had engaged in any business that competes or may compete, either directly or indirectly, with the businesses of the Group, or had any other conflict of interests with the Group. As at the Latest Practicable Date, the Company did not have any controlling Shareholder (having the meaning ascribed to it in the GEM Listing Rules).

### RECOMMENDATION

At the AGM, resolutions will be proposed for the Shareholders to approve, among other things, (i) the Repurchase Mandate; (ii) the Issue Mandate; (iii) the Extension Mandate; and (iv) the re-election of Directors.

The Directors (including the independent non-executive Directors) consider that the resolutions, including but not limited to: (i) the Repurchase Mandate; (ii) the Issue Mandate; (iii) the Extension Mandate; and (iv) the re-election of Directors as set out in the notice of the AGM are in the interests of the Company, the Group and the Shareholders as a whole and accordingly recommend all Shareholders to vote in favour of all such resolutions to be proposed at the AGM.

## **1. SHARE CAPITAL**

As at the Latest Practicable Date, the Company had 1,260,582,340 Shares in issue.

Subject to the passing of the resolution approving the Repurchase Mandate and on the basis that no Shares will be allotted, issued or repurchased by the Company prior to the AGM, the exercise of the proposed Repurchase Mandate in full would result in up to 126,058,234 Shares, representing 10% of the total number of Shares in issue, being repurchased by the Company during the period ending on the earlier of the conclusion of the next annual general meeting of the Company or the date by which the next annual general meeting of the Company is required to be held by law or the date upon which the Repurchase Mandate is revoked or varied by an ordinary resolution of the Shareholders at a general meeting of the Company.

## **2. SOURCE OF FUNDS**

The Directors propose that the repurchase of Shares under the Repurchase Mandate would be financed by the Company's internal resources.

In repurchasing the Shares, the Company may only apply funds which are legally available for such purposes in accordance with the constitutive documents of the Company, the GEM Listing Rules and the applicable laws and regulations of the Cayman Islands. The laws of the Cayman Islands provide that the amount of capital repaid in connection with a share repurchase may only be paid out of either the capital paid up on the relevant shares, or the funds of the company that would otherwise be available for distribution by way of dividend or distribution or the proceeds of a new issue of shares made for the purpose of the repurchase. It is envisaged that the funds required for any repurchase of the Shares would be derived from the capital paid up on the Shares being repurchased and from the distributable profits of the Company.

## **3. REASONS FOR SHARE REPURCHASES**

Although the Directors have no present intention of exercising the Repurchase Mandate if so granted, the Directors believe that the flexibility afforded by the Repurchase Mandate would be beneficial to the Company and the Shareholders. An exercise of the Repurchase Mandate may, depending on market conditions at the time, lead to an enhancement of the Company's net asset value and/or earnings per Share and will only be made when the Directors believe that such repurchase of Shares will benefit the Company and the Shareholders as a whole.

#### **4. SHARE PRICES**

#### **5. UNDERTAKING**

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will only exercise the powers of the Company to make repurchases pursuant to the Repurchase Mandate and in accordance with the GEM Listing Rules, the applicable laws of the Cayman Islands and the Articles.

#### **6. TAKEOVERS CODE AND PUBLIC FLOAT**

If, as a result of the Company exercising its powers to repurchase securities pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 or 32 of the Takeovers Code.

To the best of the Directors' knowledge and belief having made all reasonable enquiries, they are not aware of any consequences which may arise under the Takeovers Code as a result of any purchase made under the Repurchase Mandate. However, the Company undertakes not to repurchase Shares which would result in the amount of Shares held by the public being reduced to less than 25%.

#### **7. DISCLOSURE OF INTERESTS OF DIRECTORS AND CORE CONNECTED PERSONS**

As at the Latest Practicable Date, none of the Directors nor, to the best of their respective knowledge and belief having made all reasonable enquiries, their close associates (having the meaning ascribed to it in the GEM Listing Rules), had any present intention, if the Repurchase Mandate is approved by the Shareholders, to sell any Shares to the Company under the Repurchase Mandate.

As at the Latest Practicable Date, no core connected person (having the meaning ascribed to it in the GEM Listing Rules) of the Company had notified the Company that he/she/it had a present intention to sell any Shares or that he/she/it has undertaken not to sell any Shares held by him/her/it to the Company, in the event that the Repurchase Mandate is approved by the Shareholders.

#### **8. MATERIAL ADVERSE IMPACT**

The exercise of the Repurchase Mandate in full may have a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in its most recent published audited accounts contained in the annual report of the Company for the year ended 31 December 2018).

The Directors do not propose to exercise the power to repurchase Shares pursuant to the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in its most recent published audited accounts contained in the annual report of the Company for the year ended 31 December 2018) which, in the opinion of the Directors, are from time to time appropriate for the Company. The number of Shares to be repurchased on any occasion and the price and other terms upon which the same are purchased will be decided by the Directors at the relevant time having regard to the circumstances then pertaining.

#### **9. SHARE REPURCHASE MADE BY THE COMPANY**

The Company had not purchased any of the Shares (whether on GEM or otherwise) in the six months preceding the Latest Practicable Date.

*The following are the particulars of the Directors proposed to be re-elected at the AGM:*

**Ms. Lam Ching Yee**

Ms. Lam, aged 38, was appointed as an executive Director on 23 June 2016. She is also the chairman of the compliance committee of the Board, the compliance officer and an authorised representative of the Company. Ms. Lam is currently a director of a number of direct and indirect wholly-owned subsidiaries of the Company.

Ms. Lam obtained her Bachelor of Business Administration (Honours) in Finance from the City University of Hong Kong in 2006. Ms. Lam is a member of the Hong Kong Institute of Certified Public Accountants and has more than ten years of experience in the auditing and accounting fields. Ms. Lam is currently the company secretary and financial controller of Hang Tai Yue, a company whose shares are listed on GEM (stock code: 8081) and a substantial Shareholder (having the meaning ascribed to it in the GEM Listing Rules).

Ms. Lam has entered into a service contract with the Company for a term commencing from 1 January 2019 to 31 December 2019 (both days inclusive), unless terminated by no less than one month's notice in writing served by either party on the other, and is subject to retirement by rotation and re-election in accordance with the Articles and the GEM Listing Rules. Ms. Lam is currently entitled to an annual director's fee of HK\$360,000, which was determined by the Board with reference to her background, qualifications, experience, duties and responsibilities within the Group and the prevailing market conditions.

As at the Latest Practicable Date, save as disclosed above, Ms. Lam (i) did not hold any other major appointments and professional qualifications; (ii) did not hold any other positions with the Company or other members of the Group; and (iii) did not have any relationships with any Directors, senior management, substantial Shareholders (having the meaning ascribed to it in the GEM Listing Rules) or controlling Shareholders (having the meaning ascribed to it in the GEM Listing Rules).

As at the Latest Practicable Date, Ms. Lam did not hold any directorships in any other listed companies in the last three years and was not interested in any Shares within the meaning of Part XV of the SFO.

Save as disclosed above, there is no further information required to be disclosed pursuant to the requirements of Rule 17.50(2)(h) to (v) of the GEM Listing Rules and there are no other matters relating to the re-election of Ms. Lam that need to be brought to the attention of the Shareholders.

**Ms. Lin Ting**

Ms. Lin, aged 49, was appointed as an executive Director on 23 June 2016. She is a member of the compliance committee of the Board. Ms. Lin is currently a director of a number of indirect wholly-owned subsidiaries of the Company.

Ms. Lin graduated from the Shanghai University of Engineering Science (上海工程技術大學) with a Bachelor's degree in Industrial Enterprise Management in 1992. Ms. Lin has also obtained a Master's degree in Technology Management in Information Technology from the Hong Kong University of Science and Technology in 2004.

Ms. Lin was qualified as a project management professional by the Project Management Institute in March 2014. Ms. Lin joined the China Cargo Airlines Co., Ltd.
